Conditions of Entry

- Communities in at least one of: The Shires of Murray, Serpentine/Jarrahdale, Boddington, Waroona, and/or the City of Mandurah must be beneficiaries of the nominee's voluntary work or organisations work.
- Nominees must have made a significant contribution to the Peel Community through their volunteering or organisations efforts
- Nominees must volunteer for a Not for Profit Organisation, a Community Group or a Sporting Club
- Peel Volunteer of the Year nominees must be 25 years of age or over.
- Peel Youth Volunteer of the Year nominees must be 24 years of age or under.
- A maximum of three nominations per organisation per category is allowed.
- Nominees must not have been a **finalist** in the 2019 Peel Volunteer of the Year Awards.
- A good quality photo of the person being nominated must be attached to the nomination.
